**Obtaining a plumbing permit from Hamilton County Public Health Plumbing Division for another person or company is not permitted.** Hamilton County General Health Plumbing Rules and Regulation section II (B) State “Each person, Firm, or Corporation installing plumbing within the Hamilton County General Health District shall file a Bond with surety to be approved by the Board of Health...”

### **Inspection and Plumbing Application Review Time Frames:**

Medical Gas: 5 – 10 working days for plan review

*You must call Phil VanBenschoten at 946-7857 between 7:30 a.m. and 9:00 a.m. two working days in advance to schedule a medical gas inspection.*

Commercial Plumbing: 3- 5 working days for plan review

Same day inspection when called in between 7:30 a.m. and 9:00 a.m.

Residential Plumbing: 1-3 working days for plan review

*Same day inspection when called in between 7:30 a.m. and 9:00 a.m.*
