# Hamilton County General Health District REGULAR MEETING – BOARD OF HEALTH March 14, 2016 Minutes

#### 1. Call to Order

At 6:30 p.m., President Tracey Puthoff, called to order the regular session of the Board of Health of Hamilton County General Health District, followed by the Pledge of Allegiance.

### 3. Clean Kitchen Awards

Mr. Kesterman read the list of 11 Clean Kitchen Award recipients. One of the recipients, Mt. Washington Care Center, has received the award each year (six) since the award's inception. Mr. Schroeder accepted the award on behalf of Mt. Washington Care Center, along with congratulations and thanks from the Board of Health members.

# 5. Health Commissioner's Report

Commissioner Ingram provided a brief re-cap of the District Advisory Council meeting held March 7, 2016. He also reviewed a series of compliments received for various staff members. Two in particular were letters from the Miami Township Senior Center discussing the value of Clean Kitchen Awards and one from the Hamilton County Sheriff's office thanking Dr. Bjornson for naloxone training.

# Staff Reports

### (a) Department of Community Health Services

Mr. Davidson reported that the agency provided an update on the Zika virus to the Hamilton County Émergency Operations Team March 14. In addition, he reported on the agency initiative to provide breastfeeding policy for staff, as well as a dedicated room for pumping. Finally, Mr. Davidson reported hiring of a health educator dedicated to HIV/STD, as well as a nursing supervisor.

Ms. Puthoff inquired as to the agency's stance on promoting breastfeeding and asked that staff maintain sensitivity to women who may be unable and/or unwilling to breastfeed.

### (b) Department of Environmental Health Services

Mr. Kesterman reported that bed bug complaints have declined significantly since 2003. He attributes part of the decline to educational efforts by Environmental Health staff in remediating bed bug infestations, as well as education for tenants and property owners.

The District Licensing Council will hold its annual meeting March 23, 10 a.m. at Hamilton County Public Health.

There were five home condemnations due to unsanitary condition during the past month.

#### 6. Unfinished Business

Mr. Davidson completed 30 minutes of required training for Board of Health members, in accordance with Public Health Accreditation Standard: 12.3.1 (Diseases and Health Equity). The training consisted of a thorough review of agency efforts to reduce the incidence of syphilis and HIV. Syphilis rates, while not yet reduced to pre-epidemic levels, have declined steadily since Hamilton County Public Health assumed responsibility for STD remediation in the County.

He also reviewed the 2015 Hamilton County Child Fatality Review, covering causes of death, demographic characteristics of victims and strategies to reduce the incidence of child fatality. The report represented a detailed look at the causes of child mortality and cited work by members of the county-wide Child Fatality Review Team and its associated agencies to move Hamilton County to fatality numbers more in line with Ohio and national rates.
