WHEREAS, the Hamilton County General Health District Board of Health passed the Hamilton County General Health District Household Sewage Code Regulation 529.06: Operation Permits.

WHEREAS, the individuals on the attached list of names for delinquent sewage fees, dated August 10, 2009 have not paid for an operation permit of their household sewage disposal system as required by Hamilton County General Health District Household Sewage Code Regulation 529.06.
