# 1. Call to Order

At 6:30 p.m., President Mark Rippe called to order the regular session of the Board of Health of Hamilton County Public Health.

# 3. Approval of Minutes

# 4. Health Commissioner's Report

- a. **Power Outage -** Mr. Ingram stated that the windstorm on Sunday, September 14 caused the largest power outage in the history of the Greater Cincinnati area. Due to the power outage, staff has been working diligently to issue advisories and inform the public about food safety. A hotline has been established to assist the public with food safety information.
- b. Homebound/Special Needs Ms. Lordo reported that the Red Cross makes no provisions for homebound individuals to stay at their facility during an emergency. A special needs hotline has been established to inform the public about the MRDD facility that has been designated as a special needs shelter. The Red Cross has agreed to supply cots and food and Council on Aging is providing volunteer staffing. Hamilton County Public Health staff is also providing assistance. Mr. Ingram thanked Ms. Lordo for her hard work coordinating the facility set-up.
- c. Backflow Prevention Program Ms. Humble explained the inspection process of the backflow prevention program.
- d. Dr. Jackson Dr. Jackson, Director of Ohio Department of Health came to Cincinnati to meet with the Cincinnati Health Department and Hamilton County Public Health. Dr. Jackson toured our offices and met with staff as he answered questions and shared his vision for the future.

#### 5. Unfinished Business

a. Smoke Free Ohio
