# Hamilton County General Health District REGULAR MEETING – BOARD OF HEALTH March 11, 2013 Minutes

### 1. Call to Order

At 6:35 p.m., President, Tom Chatham called to order the regular session of the Board of Health of Hamilton County General Health District, followed by the Pledge of Allegiance.

### 3. Clean Kitchen Awards

## 5. Health Commissioner's Report – Staff Reports

Mr. Ingram congratulated Mr. Chatham on his reappointment to the Board of Health for another five year term.

Hamilton County Public Health (HCPH) has negotiated a contract with the Manufactured Homes Commission to provide mobile home park inspections in Brown County.

Mr. Ingram mentioned the draft agenda in his report regarding the retreat scheduled for May 18, 2013. He asked that the Board members contact him with anything they would like to add or change.

Hamilton County Public Health will be conducting survey focus groups with selected stakeholders within Hamilton County. The focus groups will discuss the health assessment results and what are the health needs. From this feedback, HCPH will use this information in the planning process. Ms. Lordo explained the Community Health Improvement Plan (CHIP) outlined in her report, and how this will help to form the strategic plan.

Craig Davidson, Director of Epidemiology and Assessment, provided a presentation on Hepatitis C cases reported in Hamilton County from 2003 to 2012. Aside from STD's, Hepatitis C is the highest reported communicable disease. Based on the information provided, Mr. Ingram plans to have Judith Feinberg, MD and UC Professor of Medicine attend the April Board meeting to address what can be done to reduce the number of Hepatitis C cases.

# Kathy Lordo, Assistant Health Commissioner, Department of Community Health Services

Ms. Lordo discussed the accreditation process and will provide updates each month in her report to keep the Board informed. She has been in contact with staff at Northern Kentucky Health Department regarding the accreditation process since they have already been through it. Ms. Lordo stated they have been very helpful.

# **Greg Kesterman, Assistant Health Commissioner, Department of Environmental Health Services**

Mr. Kesterman discussed the odor complaints at Rumpke Sanitary Landfill. He also discussed the new odor control blanket formulation that Rumpke plans to use in 2013 and he provided samples of the blanket layers that will be used.

Mr. Ingram discussed the contents of the HCPH 2012 annual report and prior year accomplishments.
