1. Call to Order

At 6:30 p.m., Vice President, Jim Brett, called to order the regular session of the Board of Health of Hamilton County General Health District followed by the Pledge of Allegiance.

The Board congratulated Kathy Lordo on receiving the 2011 Hamilton County Employee of the Year-Innovation Category award. Mr. Brett read an excerpt from her nomination from County Commissioner, Chris Monzel.

The Ohio Tuberculosis (TB) Coalition selected Joel Hoskins as the honored recipient of the 2011 Dr. Charles B. Payne Memorial award for outstanding leadership and effort toward the elimination of TB in Ohio. The Board members congratulated Mr. Hoskins and thanked him for his exceptional public health service in Hamilton County.

Resolution G-2012 - Honoring Mary Sacco

Mr. Brett read Resolution G-2012, honoring Mary Sacco, for her 24 years of service to Hamilton County Public Health as the Director of Nursing. All Board members, and Mr. Ingram, thanked her for her dedication and wished her well on her retirement.

5. Health Commissioner's Report

Mr. Ingram reported on the Hamilton County Budget Commission meeting where the HCPH 2013 budget was unanimously approved.

Mr. Ingram discussed parts of the Ohio Legislation that will impact Hamilton County Public Health (HCPH). The transfer of the Manufactured Home inspection program, from Boards of Health to the Manufactured Home Commission, will remain intact.

The authority for the Boards of County Commissioners to charge Health Districts rent has been put unto a separate bill, HB 509. A meeting is scheduled for Tuesday, May 15, where Mr. Ingram is hoping for a compromise. He will keep the Board informed on any decisions.

Mr. Ingram congratulated Joel Hoskins, Kathy Lordo, and Mary Sacco. He thanked them for their hard work and dedication to HCPH.

Staff Reports

Kathy Lordo, Assistant Health Commissioner, Department of Community Health Services

Ms. Lordo reported on Nursing Division updates. To date, there have been no complaints regarding the changes to the immunization schedule. The Flu Collaborative group, which was chaired by Ms. Sacco, expressed interest in continuing to meet. Pat Allingham will now chair the committee

Ms. Lordo discussed the re-organization of the Division of Epidemiology and the Division of Disease Prevention and Nursing.

The STD/HIV Prevention program is moving smoothly and is fully staffed. Mr. Rippe mentioned a phone application, STDiQ, and suggested that Ms. Lordo check into this.

Greg Kesterman, Assistant Health Commissioner, Department of Environmental Health Services

Mr. Kesterman reported on the completion of the Odor Control Blanket (OCB) at Rumpke Sanitary Landfill. Rumpke was fined \$56,041.00 for failing to "strictly control odors". He also discussed the fire at the Rumpke St. Bernard recycling facility.

The Division of Environmental Health (EH) employed Ana Rojas-Moonitz in 2011. Since her first language is Spanish, the Division has been able to minimize language barriers in inspections as well as education courses provided by EH.
