1. Call to Order

At 6:30 p.m., Vice President, Dr. Amend, called to order the regular session of the Board of Health of Hamilton County General Health District, followed by the Pledge of Allegiance.

3. Clean Kitchen Awards

4. Presentation: Judith Feinberg, MD and UC Professor of Medicine

"The Rise in Hepatitis and Other Blood-borne Diseases Due to IV Drug Use"

Dr. Feinberg presented her rationale for creating a syringe exchange program in Hamilton County. Details of her presentation are attached.

Per Board request, Adam Reilly will provide Mr. Ingram data from Cleveland that illustrates the before and after of the syringe exchange program.

Mr. Ingram introduced Jim Schwab and Ann Barnham from the Greater Cincinnati Health Foundation. Mr. Schwab discussed the Greater Cincinnati Health Foundation Board's support for the syringe exchange program.

6. Health Commissioner's Report – Staff Reports

Mr. Ingram introduced Ms. Laura Wojtys, a Fellow from Miami University in the Public Administration Program, who has been shadowing Mr. Ingram's office.

Mr. Ingram presented Miami Township Trustee, Joe Sykes, Resolution A-2013, recognizing his retirement and years of service to Hamilton County Public Health (HCPH) and the District Advisory Council.

Mr. Ingram mentioned the retreat and the hiring of a facilitator who will contact the Board members with three questions pertaining to the retreat.

Mr. Kesterman discussed the application for the Samuel J. Crumbine Award in the Division of Environmental Health.

For the first quarter, Environmental Health (EH) had an increase in the number of licensed facilities for the Food Service Operations and Retail Food Establishments. They have also received \$44,000 in fine payments for Smoke Free Ohio.

Mr. Kesterman discussed a new mobile technology that the Division of Waste Management, in coordination with Environmental Services, is using to capture odor complaints at Rumpke Landfill.

Hamilton County Public Health (HCPH) is in the process of soliciting comments pertaining to the revision of Regulation 529 governing sewage treatment systems. The Board of Health, along with registered contractors, housing associations, realtors, environmental groups, and other interested parties were contacted and offered an opportunity to comment on the rules. Once the comments are compiled, this information will be shared with Board members as part of the process.
