Current Situation:

Hamilton County Public Health (HCPH), the Ohio Department of Health (ODH), Centers for Disease Control and Prevention (CDC) and World Health Organization (WHO) are closely monitoring an outbreak of respiratory illness caused by a novel (new) coronavirus (termed “COVID-19”) first identified in Wuhan City, Hubei Province, China in December 2019 and which continues to expand.



Coronavirus (COVID-19):

COVID-19 is a respiratory disease that can result in a serious illness or death, is caused by the SARS-CoV-2 virus, which is a new strain of coronavirus that had not been previously identified in humans and can easily spread from person to person. The virus is spread between individuals who are in close contact with each other (within about six feet) through respiratory droplets produced when an infected person coughs or sneezes. It may be possible that individuals can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose or eyes.

- May 20, 2020 ODH Director issued an [Urgent Health Advisory](#) to people 65 years or older and all people with underlying medical conditions to stay in their residence to the extent possible.
- May 20, 2020 ODH issued an [Order](#) that Reopens Campgrounds, with Exceptions.
- May 20, 2020 ODH issued an [Order](#) that Recinds and Modifies Portions of the Stay Safe Ohio Order.
- May 22, 2020 ODH issued an [Order](#) that Reopens Gyms, Dance Instruction Studios and Other Personal Fitness Venues, with Exceptions.
- May 22, 2020 ODH issued an [Order](#) that Provides Guidance for Baseball, Softball, Batting Cages, Golf Courses, Miniature Golf, Local and Public Pools and Aquatic Centers, Tennis Facilities, Skills Training for All Sports, and General Non-Contact Sports including Bowling Alleys, with Exceptions.
- May 22, 2020 ODH issued a [Third Amended Order](#) for the Closure of All K-12 Schools in the State of Ohio.
- May 28, 2020 ODH Director issued a Director’s [Order](#) for the Testing of the Residents and Staff of all Nursing Homes.
- May 29, 2020 ODH Director issued a Director’s [Order](#) that Rescinds the Director’s Order that the Sale of Spirituous Liquor be Restricted in Certain Instances in Certain Counties.
- May 29, 2020 ODH Director issued the Director’s Updated and Revised [Order](#) for Business Guidance and Social Distancing.
- May 29, 2020 ODH Director issued Director’s [Order](#) that Reopens Facilities Providing Child Care Services, with Exceptions.
- June 2, 2020 ODH Director issued a Director’s [Order](#) for the Testing of the Residents and Staff of all Nursing Homes.
- June 4, 2020 ODH Director issued a Director’s [Order](#) that Reopens Youth Day Camps and Residential Camps, with Exceptions.
- June 5, 2020 ODH Director issued a Director’s [Order](#) (Third Amended) to Limit Ohio’s Nursing Homes and Similar Facilities, with Exceptions.
- June 8, 2020 ODH Director issued an Amended Director’s [Order](#) that Reopens Restaurants, Bars Banquet and Catering Facilities and Services to Dine-in Service, with Exceptions.



HCPH Update:

- Within HCPH service jurisdictions, there are 1,797 residents that have been tested positive for COVID-19. Of those 1,797 residents, there are 374 hospitalized, 116 deaths and 776 have recovered.
- Within Hamilton County (including HCPH, Cincinnati, Norwood and Springdale), there are 3,370 confirmed COVID-19 cases, 638 hospitalizations and 182 deaths.
- HCPH managing a network of trained “contact tracers” consisting of county department staff members and temporary contract personnel to conduct contact tracing on residents testing positive for COVID-19.
- HCPH Epi staff are communicating daily with long-term care facilities, group homes and local businesses having COVID-19 outbreaks. COVID-19 nasopharyngeal specimen collection kits are being provided to these facilities as necessary.
- HCPH has developed and continues to use a series of surveys created in Qualtrics to conduct case interviews and contact follow-up. This innovative tool is utilized by the contractors hired to conduct contact tracing. Several other Ohio local health departments have reached out to HCPH to learn how HCPH has used Qualtrics to streamline the contact tracing process.
- The EH Division continued addressing business complaints related to what is needed to open safely and in accordance with COVID-19 social distancing guidelines. Below is list of business complaints over the last 8 weeks:

- HCPH’s Environmental Health (EH) Division staff continued restaurant inspections as part of the Governor’s plan to reopen Ohio.
- HCPH continues to respond to all media requests.
- HCPH continues updating its website on an as-needed basis with COVID-19 information.
- On 6/10/20, HCPH distributed Situation Report #18 to its POD Managers, Fire/Police Chiefs and to Hamilton County EMHSA for distribution.
- On 6/10/20, HCPH received a shipment of PPE from ODH. PPE included 55,000 KN95 masks and 136,000 surgical masks.
- On 6/15/20, HCPH received a shipment of PPE from ODH. PPE included 38,500 gowns, 422 infrared thermometers and 110,000 surgical masks.
- HCPH participating in a weekly conference call with regional Emergency Response Coordinators to share information related to the COVID-19 response.



- HCPH continues to identify and provide guidance to vulnerable and at-risk populations affected by the COVID-19 pandemic.
- HCPH conducting essential inspections while ensuring that everyone is maintaining the required six foot distance. In addition, we are providing masks for inspectors and front line workers to comply with CDC recommendations.
- Adjusted clinical and needle exchange services to appointment only to reduce patient volume in waiting rooms.
- HCPH is part of Hamilton County EMHSA's Emergency Operations Center (EOC). The EOC emergency activation level is Level 2 – Partial EOC Activation. HCPH is participating in the virtual EOC and supporting Emergency Support Function (ESF) #8 – Public Health & Healthcare Providers.
- HCPH participating in a weekly EOC conference call with Hamilton County EMHSA and the Health Collaborative to discuss ESF-8 updates. HCPH and The Health Collaborative are co-leads for coordinating ESF-8 activities.
- HCPH participating in local, regional and statewide conference calls to discuss COVID-19 response efforts.
- HCPH reaching out to long-term care, skilled nursing and independent living facilities throughout HCPH-service jurisdictions that have elderly patients and/or residents to ensure they are receiving important COVID-19 information and to ensure their Point of Dispensing Plans are up to date.
- HCPH updated POD plans from skilled nursing, assisted living and hospice facilities within its POD Program. A total of 45 POD plans have been updated to date.
- HCPH staff that are able to telecommute are doing so. HCPH is practicing social distancing by not hosting meetings or going to meetings for the time being. Teleconferencing (WebEX, Zoom, etc) is being conducted.
- HCPH regularly briefs the county commissioners and Board of Health.
- HCPH's incident management team includes the Interim Health Commissioner, Assistant Health Commissioner, Director of Nursing, Director of Disease Prevention, Director of Epidemiology, Senior Epidemiologist, Public Information Officer and the Emergency Response Coordinator.
- HCPH is emphasizing social distancing, teleworking and teleconferencing.

Upcoming HCPH Activities:

- Continue working in the Hamilton County EOC and participating in weekly conference calls.
- Continue conducting contact tracing and COVID-19 outbreak investigations.
- Continue working with our long-term care, skilled nursing, hospice facilities and home health agencies in our POD Program to update each of their POD Plans.
- Continue distributing COVID-19 test kits to long-term care facilities, as needed.
- Continue updating community and preparedness partners with updated COVID-19 guidance.
- Continue stressing the importance of social distancing.
