

REGULATION 3- 2007

ADOPTING AND/OR REVISING PRIVATE WATER SYSTEM (PWS) FEES FOR PWS VARIANCES, PWS INSTALLATION APPLICATION FOR SINGLE FAMILY DWELLING, PWS SAMPLES, PWS ABANDONMENTS FOR SINGLE FAMILY DWELLING, PWS INSTALLATION APPLICATION FOR NON-SINGLE FAMILY DWELLING, AND PWS ABANDONMENTS FOR NON-SINGLE FAMILY DWELLING

The Board of Health of the Hamilton County General Health District met in regular session on the fourteenth day of May 2007, with the following members present:

Mr. Brett moved for adoption of the following regulation:

Regulation 3-2007 adopting and/or revising Private Water System (PWS) fees, pursuant to Ohio Revised Code (ORC), Sections 3709.09, 3709.21, and 3701.344 for PWS Variances, PWS Installation Application for Single Family Dwelling, PWS Samples, PWS Abandonments for Single Family Dwelling, PWS Installation Application for Non-Single Family Dwelling, and PWS Abandonments for Non-Single Family Dwelling

WHEREAS, the Board of Health of the Hamilton County General Health District has the authority pursuant to Ohio Revised Code Sections 3709.09, 3709.21, and 3701.344 to establish a uniform system of fees for services; and

WHEREAS, the Board of Health of the Hamilton County General Health District is mandated to provide services that protect the public health and prevent disease; and

WHEREAS, the Board of Health of the Hamilton County General Health District has determined it necessary to adopt and or revise fees in order to cover costs of programs to protect public health; and

WHEREAS, the Board of Health of the Hamilton County General Health District has determined it is necessary to adopt and/or revise the Private Water System (PWS) fees for **PWS Variances, PWS Installation Application for Single Family Dwelling, PWS Samples, PWS Abandonments for Single Family Dwelling, PWS Installation Application for Non-Single Family Dwelling, and PWS Abandonments for Non-Single Family Dwelling**

WHEREAS, any entity that would be affected by the adoption and/or revision to the Private Water System (PWS) fees for PWS Variances, PWS Installation Application for Single Family Dwelling, PWS Samples, PWS Abandonments for Single Family Dwelling, PWS Installation Application for Non-Single Family Dwelling, and PWS Abandonments for Non-Single Family Dwelling was advised of the amount of the adopted and/or revised fee by the Board of Health of the Hamilton County General Health District at least thirty (30) days prior to establishing the fee pursuant to Ohio Revised Code Section 3709.09 (C); and

NOW, THEREFORE, BE IT RESOLVED that the Board of Health of the Hamilton County General Health District hereby adopts the following revised Private Water System (PWS) fee schedule for PWS Variances, PWS Installation Application for Single Family Dwelling, PWS Samples, PWS Abandonments for Single Family Dwelling, PWS Installation Application for Non-Single Family Dwelling, and PWS Abandonments for Non-Single Family Dwelling to become effective June 1, 2007.

FEE SCHEDULE

Fee Category	Fee
1. PWS Variances	\$155.00
2. PWS Installation Application, Single Family Dwelling (includes \$50 state fee)	\$250.00
3. PWS Sample (Includes total coliform sample fee)	\$ 50.00
4. PWS Abandonments, Single Family Dwelling	\$ 45.00
5. PWS Installation Application, Non-Single Family Dwelling (includes \$50 state fee)	\$300.00
6. PWS Abandonments, Non-Single Family Dwelling	\$ 55.00

BE IT FURTHER RESOLVED, that any previous regulation, rule, or policy adopted by the Board of Health of the Hamilton County General Health District, that in any way conflicts with this regulation in part or in whole, is hereby rescinded and repealed in part or in whole to the extent of any conflict; and

BE IT FURTHER RESOLVED, that the Board of Health of the Hamilton County General Health District hereby finds by a vote of at least three-fourths of its members that this regulation be read only once, and the requirement that it be read on three different days be dispensed with as provided by law; and

BE IT FURTHER RESOLVED, by this Board of Health of the Hamilton County General Health District, that this regulation be published in one newspaper of general circulation within the Hamilton County General Health District once a week for two consecutive weeks and that the first publication take place no later than ten (10) days prior to the effective date of the Regulation; and

BE IT FURTHER RESOLVED, that this Board of Health of the Hamilton County General Health District find and determine that all formal actions relative to the passage of this regulation were taken in an open meeting of this Board and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with the applicable legal requirement, including Sections 121.22 of the Ohio Revised Code.
