REGULATION 5-2019

REGULATION ADOPTING REVISED LOCAL FEES FOR PUBLIC ACCOMODATION FACILITIES

The Board of Health of the Hamilton County General Health District met in regular session on October 14, 2019 with the following members present:

Mr. Rippe moved for adoption of the following regulation:

Regulation 5-2019 adopting revised fees pursuant to the Ohio Revised Code 3709.09 and Hamilton County General Health District Sanitation Regulation 1-2009, for public accommodation facilities.

WHEREAS, the Board of Health of the Hamilton County General Health District has the authority pursuant to the Ohio Revised Code 3709.09 and Hamilton County General Health District Sanitation Regulation 1-2009 to establish a uniform system of fees for services; and

WHEREAS, the Board of Health of the Hamilton County General Health District is mandated to provide services that protect the public health and prevent disease; and

WHEREAS, the Board of Health of the Hamilton County General Health District licenses and inspects all public accommodation facilities within its jurisdiction; and

WHEREAS, the Board of Health of the Hamilton County General Health District has determined it is necessary to revise the fees for public accommodation facilities Ohio Revised Code 3709.09 and Hamilton County General Health District Sanitation Regulation 1-2009; and

WHEREAS, any entity that would be affected by the revision to the local fees were advised by the Board of Health of the Hamilton County General Health District at least twenty (20) days prior to establishing the revised fees pursuant to Ohio Revised Code 3709.09

NOW, THEREFORE BE IT RESOLVED that the Board of Health of the Hamilton County General Health District hereby adopts the revised local fee schedule as follows for public accommodation facilities, effective November 1, 2019:

Local Fees: \$145.00 Base fee up to fifty rooms

\$3.50 Additional rooms

Late Fees Pursuant to Hamilton County General Health District Sanitation Regulation 1-

2009-03, if an application and fee is submitted or post marked after this date or received as a partial payment, the operator will be required to pay a late fee of twenty-five percent of the cost of the permit in addition to the regular fee.

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District hereby finds by a vote of at least three-fourths of its members that this regulation be read only once and the requirement that it be read on three different days be dispensed with as provided by law; and

BE IT FURTHER RESOLVED that any previous regulation, rule or policy adopted by the Board of Health of the Hamilton County General Health District, that in any way conflicts with this regulation in part or in whole is rescinded and repealed in part or in whole to the extent of any conflict; and

BE IT FURTHER RESOLVED by this Board of Health of the Hamilton County General Health District that the regulation be published in one newspaper of general circulation within the Hamilton County General Health District once a week for two consecutive weeks and that the first publication take place no later than ten (10) days prior to the effective date of the regulation;

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District finds and determines that all formal actions relative to the passage of this regulation were taken in an open meeting of the Board and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with the applicable legal requirement, including Ohio Revised Code 121.22.
