REGULATION ADOPTING REVISED LOCAL FEES FOR SEWAGE TREATMENT SYSTEMS, GREY WATER RECYCLING SYSTEMS, SMALL FLOW ONSITE TREATMENT SYSTEMS, AND SEMI PUBLIC SEWAGE TREATMENT SYSTEMS

Mv, Rippe moved for adoption of the following regulation:

Regulation 1-2019 adopting revised fees for activities related to Sewage Treatment Systems, Grey Water Recycling Systems, Small Flow Onsite Treatment Systems, and Semi Public Sewage Treatment Systems.

WHEREAS, the Board of Health of the Hamilton County General Health District has the authority pursuant to the Ohio Revised Code Sections 3709.09, 3709.21 and 3718.06 to establish a uniform system of fees for services; and

WHEREAS, the Board of Health of the Hamilton County General Health District is mandated to provide services that protect the public health and prevent disease; and

WHEREAS, the Board of Health of the Hamilton County General Health District permits, registers, and inspects all sewage treatment systems, grey water recycling systems, small flow onsite treatment systems, semi-public sewage treatment systems, installers, service providers, and septage haulers within its jurisdiction; and

WHEREAS, the Board of Health of the Hamilton County General Health District has determined it is necessary to adopt revised fees for activities related to sewage treatment systems, grey water recycling systems, small flow onsite treatment systems, and semi-public sewage treatment systems pursuant to Ohio Revised Code, Chapter 3718 and Ohio Administrative Code, Chapter 3701-29; and

WHEREAS, any entity that would be affected by the revision to the fees for sewage treatment systems, grey water recycling systems, small flow onsite treatment systems, and semi-public sewage treatment systems were advised in writing by the Board of Health of the Hamilton County General Health District at least twenty (20) days prior to establishing the revised fees pursuant to Ohio Revised Code Section 3709.09; and

NOW, THEREFORE BE IT RESOLVED that the Board of Health of the Hamilton County General Health District hereby adopts the revised local fee schedule as follows for activities related to sewage treatment systems, grey water recycling systems, small flow onsite treatment systems, and semi-public sewage treatment systems, effective February 1, 2019:

State Fees

In addition to the local fee, a state fee portion, which is specified by the Ohio Revised Code or Administrative Codes, will be added.

Late Fees

Pursuant to Ohio Revised Code 3709.09 if payment of a fee established under this section is not received by the day on which payment is due, the board of health shall assess a penalty, as required by law.

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District hereby finds by a vote of at least three-fourths of its members that this regulation be read only once and the requirement that it be read on three different days be dispensed with as provided by law; and

BE IT FURTHER RESOLVED that any previous regulation, rule or policy adopted by the Board of Health of the Hamilton County General Health District, that in any way conflicts with this regulation in part or in whole is rescinded and repealed in part or in whole to the extent of any conflict; and

BE IT FURTHER RESOLVED by this Board of Health of the Hamilton County General Health District that the regulation be published in one newspaper of general circulation within the Hamilton County General Health District once a week for two consecutive weeks and that the first publication take place no later than ten (10) days prior to the effective date of the regulation;

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District finds and determines that all formal actions relative to the passage of this regulation were taken in an open meeting of the Board and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with the applicable legal requirement, including Sections 121.22 of the Ohio Revised Code.
