RESOLUTION A–2009, Appointment of the Health Commissioner to Local Registrar of Vital Statistics for Hamilton County General Health District

WHEREAS, the Board of Health of the Hamilton County General Health District has the authority pursuant to Ohio Revised Code Section 3705.05 upon recommendation of the Health Commissioner to appoint the local registrar of vital statistics; and

WHEREAS, the Board of Health of the Hamilton County General Health District is mandated to provide services that protect the public health and prevent disease; and

WHEREAS, the Ohio Department of Health and the U.S. Department of Homeland Security has issued directives for vital statistics in order to prevent identity theft and other security mandates due to the sensitive information found on vital statistics records; and

WHEREAS, the Health Commissioner has a fiduciary relationship with the Board of Health of the Hamilton County General Health District; and

WHEREAS, the Health Commissioner for the Board of Health of the Hamilton County General Health District has recommended to the Board of Health that the Health Commissioner be appointed the local registrar of vital statistics; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Health of the Hamilton County General Health District appoints the Health Commissioner as the local registrar of vital statistics, effective March 1, 2009; and

BE IT FURTHER RESOLVED that any previous regulation, rule, or policy adopted by the Board of Health of the Hamilton County General Health District, that in any way conflicts with this resolution in part or in whole, is hereby rescinded and repealed in part or in whole to the extent of any conflict; and

BE IT FURTHER RESOLVED, by this Board of Health of the Hamilton County General Health District, that this resolution and proper notice be provided to the Ohio Department of Health; and

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting of the Board and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with the applicable legal requirement, including Sections 121.22 of the Ohio Revised Code.
