RESOLUTION REPEALING BOARD OF HEALTH REGULATION 529

The Board of Health of the Hamilton County General Health District met in regular session on September 14, 2015, with the following members present:

Dr. Amend moved for adoption of the following resolution:

Resolution repealing Board of Health Regulation 529

WHEREAS, the Board of Health of the Hamilton County General Health District has the authority pursuant to the Ohio Revised Code Section 3709.21 to make such orders and regulations for its own government, for the public health, for the prevention or restriction of disease or nuisances, and in the event of an emergency due to an epidemic of contagious or infectious diseases, to declare such orders as emergency measures; and

WHEREAS, the Board of Health of the Hamilton County General Health District adopted Regulation 529 on July 16, 2007 and subsequently revised Regulation 529 on June 10, 2013; and

WHEREAS, the Ohio Department of Health adopted the Ohio Administrative Code section 3701-29, Sewage Treatment System Rules, in order to protect the public health and to prevent or restrict the spread of disease and nuisances; and

NOW, THEREFORE BE IT RESOLVED that pursuant to Ohio Revised Code Section 3709.21, the Board of Health of the Hamilton County General Health District hereby repeals Regulation 529 effective January 1, 2015;

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District hereby finds by a vote of at least three-fourths of its members that this resolution be read only once and the requirement that it be read on three different days be dispensed with as provided by law; and

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health

District finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting of the Board and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with the applicable legal requirement, including Sections 121.22 of the Ohio Revised Code.
