**RESOLUTION FOR SUPPLEMENTAL APPROPRIATION TO THE 2021 REVISED BUDGET, EFFECTIVE JULY 12, 2021**

**WHEREAS**, the Board of Health has agreed with the Health Commissioner's request to increase salaries and the appropriate salary ranges by \$2.00 per hour for staff who earn \$50,000 or less annually and by \$1.50 per hour for all other staff;

**NOW THEREFORE BE IT RESOLVED** that the Board of Health of the Hamilton County General Health District hereby approves the supplemental appropriation to the 2021 budget and authorizes additional personnel spending by a total of \$134,824 at the fund and object one level of control, as follows;


