WHEREAS, Ohio Revised Code Section 3718.02 and Ohio Administrative Code Sections 3701-29-09 and 3701-29-19 authorizes a Board of Health to make inspections of household sewage treatment systems (rule adopted under Ohio Revised Code 3718); and

WHEREAS, the Hamilton County General Health District Board of Health approved Regulation 8-2014, adopting fees for sewage treatment systems including operation permits in accordance with Ohio Revised Code Sections (ORC) 3709.09, 3718.06, and 3709.21; and

WHEREAS, the individuals on the attached list of names for delinquent sewage fees, dated August 9, 2021 have not paid for an operation permit of their sewage treatment system as required by the Ohio Administrative Code 3701-29 and ORC Sections 3709.09 and 3718.06; and


