WHEREAS, Ohio Revised Code Section 3718.02 and Ohio Administrative Code Sections 3701-29-09 and 3701-29-19 authorizes a Board of Health to make inspections of household sewage treatment systems (rule adopted under Ohio Revised Code 3718); and

WHEREAS, the Hamilton County General Health District Board of Health approved Regulation 8-2014 and Regulation 1-2019, adopting fees for sewage treatment systems including operation permits in accordance with Ohio Revised Code Sections (ORC) 3709.09, 3718.06, and 3709.21; and

WHEREAS, the individuals on the attached list of names for delinquent sewage fees, dated August 12, 2019 have not paid for one or more operation permit inspections of their sewage treatment system as required by the Ohio Administrative Code 3701-29 and ORC Sections 3709.09 and 3718.06; and

NOW, THEREFORE, BE IT RESOLVED that the Board finds that the individuals on the attached list of names dated August 12, 2019 have been given notice and all the additional requirements as mandated under Ohio Revised Code Section 3709.091; and

BE IT FURTHER RESOLVED, that under the authority of Ohio Revised Code Section 3709.091(E), the Hamilton County General Health District Board of Health certifies the attached list of names dated August 12, 2019 with the amount of unpaid fees and any accrued late fees

to the Hamilton County Auditor's Office to be placed on the General Tax List and duplicate as provided in Section 319.281 of the Ohio Revised Code.




