**WHEREAS**, the Hamilton County General Health District Board of Health passed the Hamilton County General Health District Household Sewage Code Regulation 529.06: Operation Permits.

**WHEREAS**, the individuals on the attached list of names for delinquent sewage fees, dated August 13, 2012 have not paid for an operation permit of their household sewage disposal system as required by Hamilton County General Health District Household Sewage Code Regulation 529.06.

**NOW, THEREFORE, BE IT RESOLVED** that the Board finds that the individuals on the attached list of names dated August 13, 2012 have been given notice and all the additional requirements as mandated under Ohio Revised Code Section 3709.091.

**BE IT FURTHER RESOLVED**, that under the authority of Ohio Revised Code Section 3709.091(e), the Hamilton County General Health District Board of Health certifies the attached list of names dated August 13, 2012 with the amount of unpaid fees and any accrued late fees to the Hamilton County Auditor's Office to be placed on the General Tax List and duplicate as provided in Section 319.281 of the Ohio Revised Code.
