Medical Gas

As part of a shared service agreement between the City of Cincinnati and Hamilton County, Hamilton County Public Health (HCPH) will begin inspections of nonflammable medical gas facilities and installations beginning October 1, 2016. HCPH will continue to inspect and issue permits in Brown, Warren and Hamilton Counties, as well as the City of St. Bernard. Clermont County has resumed its own medical gas program as of June 1, 2016.


