

REGULATION 1-2007

ADOPTING REVISED FEES FOR RECREATIONAL VEHICLE PARKS, RECREATION CAMPS, AND COMBINED PARK-CAMPS.

The Board of Health of the Hamilton County General Health District met in regular session on February 12, 2007 with the following members present:

Regulation 1-2007 declaring the adoption of revised fees pursuant to the Ohio Revised Code Sections 3709.09 and 3729.07 for Recreational Vehicle Parks, Recreation Camps, and Combined Park-Camps

WHEREAS, the Board of Health of the Hamilton County General Health District has the authority pursuant to Ohio Revised Code Section 3709.09 and Section 3729.07 to establish a uniform system of fees for services; and

WHEREAS, the Board of Health of the Hamilton County General Health District is mandated to provide services that protect the public health and prevent disease; and

WHEREAS, the Board of Health of the Hamilton County General Health District licenses and inspects all parks, camps, and park-camps under its jurisdiction; and

WHEREAS, the Board of Health of the Hamilton County General Health District has determined it necessary to revise fees for parks, camps, and park-camps pursuant to Ohio Revised Code, Chapter 3729 and Ohio Administrative Code 3701-25, as may be amended; and

WHEREAS, any entity that would be affected by the revision of fees for parks, camps, and park-camps was advised of the amount of the revised fee by the Board of Health of the Hamilton County General Health District at least thirty (30) days prior to establishing the fee pursuant to Ohio Revised Code Section 3709.09 (C); and

NOW, THEREFORE, BE IT RESOLVED that the Board of Health of the Hamilton County General Health District establishes the following revised fee schedule, as directed by the State of Ohio per Ohio Administrative Code 3701-25, as may be amended, for parks, camps, and park-camps to become effective May 1, 2007.

**PROPOSED LICENSE FEE SCHEDULE
Parks, Camps, and Park-Camps**

Fee: Base - \$75.00 for each camp with 50 or fewer sites; and
\$4.00 for each additional site exceeding 50 sites

The local cost of a license for parks, camps, and park-camps shall include a state fee portion, which is determined by the Public Health Council pursuant to the Ohio Revised Code.

BE IT FURTHER RESOLVED by this Board of Health of the Hamilton County General Health District, that the Environmental Health Director hereby notified all entities that would be affected by the revised fees at least thirty (30) days prior to the next Board of Health meeting at which time the fees may be established.

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District hereby finds by a vote of at least three-fourths of its members that this regulation be read only once and the requirement that it be read on three different days be dispensed with as provided by law; and

BE IT FURTHER RESOLVED that any previous regulation, rule, or policy adopted by the Board of Health of the Hamilton County General Health District, that in any way conflicts with this regulation in part or in whole, is hereby rescinded and repealed in part or in whole to the extent of any conflict; and

BE IT FURTHER RESOLVED, by this Board of Health of the Hamilton County General Health District, that the regulation be published in one newspaper of general circulation within the Hamilton County General Health District once a week for two consecutive weeks and that the first publication take place no later than ten (10) days prior to the effective date of this regulation of the Hamilton County Board of Health; and

BE IT FURTHER RESOLVED that the Board of Health of the Hamilton County General Health District finds and determines that all formal actions relative to the passage of this regulation were taken in an open meeting of the Board and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with the applicable legal requirement, including Sections 121.22 of the Ohio Revised Code.
